

### UN Statistical Commission 2022 Decision 28: Governance, peace and security statistics (Item 3y)

The Statistical Commission:

- a) Welcomed the report; acknowledged and **supported the work of the Praia Group on Governance Statistics**; and appreciated the products developed, particularly the COVID-19 guidance note;
- b) Commended the Handbook on governance statistics to be used for producing national statistics on governance especially for monitoring and implementing SDG 16; noted that there are methodological elements in the production of governance statistics that require more attention; and noted that they should be consistent with the 2030 Agenda.
- c) Supported the workplan of the Praia Group for the period 2020–2025 and its three pillars:
  - a) improving and standardizing methodologies to measure governance
  - b) strengthening the capacities of statistical offices to produce reliable statistics on governance, and
  - c) advocacy to increase the demand for governance statistics and to mobilize national and international resources to facilitate producing those statistics;
- d) Welcomed the establishment of the task teams on non-discrimination and equality, and on participation in political and public affairs, supported their workplans, encouraged broad participation, especially from African countries, in the work of these task teams, and supported the establishment of additional task teams on other dimensions of governance that require further methodological work while ensuring synergies and coordination with other relevant workstreams.

### Voter registration methods

### Active voter registration

#### Voter-initiated

- Voters have the <u>responsibility</u> to register (i.e. to apply to be included into a voter's register), or to <u>update</u> changes to personal information to ensure eligibility (e.g. residency)
- Done either prior to each election (periodic) or on an ongoing basis (continuous)

Most common method of voter registration (used in around 150 nations/ territories)

### Passive voter registration

#### > State-initiated

 Voters are automatically registered by national or local authorities based on civil records or registries (e.g. civil registries, national ID records, driver's license databases or tax records)

#### Used in 20-30 nations/ territories






#### Is voting on the national level voluntary or compulsory?




#### What is the legal voting age in the national elections?




#### Beyond age, what other qualifications exist for registering to vote and voting in the national elections?
